- 1.Personal Data requested by using this form is required to provide "Service" to the delegate and these personal data are protected by NTSS Ltd.Şti.
- 2.Personal data belong to the delegate can be processed by NTSS Ltd.Şti. as explained in the <u>Data Protection Policy</u> in accordance to Law no. 6698 on Protection of Personal Data. Delegate has right to revoke his/her permission for processing his/her personal data anytime.
- 3. The Delegate has the right to receive information about the following matters related to his/her personal data that he / she has entered at his / her own expedition. This application can be made by an e-mail to dpo@ntss.com.tr.
 - a) To know whether personal data is processed or not,
 - b) Requesting information about personal data if it has been processed,
 - c) To know the purpose of their personal data being processed and whether they are used appropriately for their purpose,
 - c) Knowing the third parties to which personal data are transferred in Turkey or abroad,
 - d) In the event that personal data is missing or incorrectly processed, making a request for their correction,
 - e) Requesting deletion or destruction of personal data in accordance with the conditions set out below,
 - e.1) Personal data shall be deleted, destroyed or anonymized by the Data Officer on the request of the person concerned or the reasons to process the data is lifted, even though it has been processed in accordance with Law No. 6698 and other related laws.
 - e.2) The provisions of other laws related to the deletion, destruction or the anonymization of personal data are reserved.
 - e.3) The procedures and principles regarding the deletion, destruction or anonymization of personal data shall be regulated with regulations.
 - f) For the processes that are done in accordance with (d) and (e), requesting third persons to be notified who receive the transfer of personal data,
 - g) Objection to the occurrence of a consequence against the person himself by analyzing the processed data exclusively through automated systems.
 - ğ) Demanding that damages be eliminated in the event of a corruption due to the processing of personal data against the law,
- 4. The Delegate's personal data is not given to third parties in any way other than appropriate court / public prosecutor's decisions given in accordance with the law, legal exceptions and the Delegate giving a written consent to give person's personal information to third parties.
- 5. In the direction of technological developments, while NTSS Ltd.
